Minutes of the Annual Board Meeting

January 8th, 2022

Attendees: Board members including: Charlie Hirsch, Greg Wooden, Judy Wooden, Jim Mallon, Monica Mallon, Mike Lancaster, Dan Conrad, Kent Ketterling, Myron Reed, Kelly Thornbury and additional members.

Meeting was called to order at 6:12pm by Board Vice President, Greg Wooden.

Treasures report was presented by Board Treasurer, Monica Mallon. Report was reviewed and discussed. Motion to approve was made by Dan Conrad, second by Myron Reed.

Proposed Budget was presented by Board Treasurer, Monica Mallon. Judy Wooden proposed adding a \$500.00 donation to the budget for the CFA Scholarship Foundation. Lora Ketterling, President of CFASF answered a couple of questions about how the foundation awarded scholarships. Membership approved. The budget was approved with the additional \$500 by Dan Conrad, seconded by Myron Reed.
