Minutes of the Monthly Board Meeting

November 14th, 2022

Meeting was called to order at 7:05pm by Board President, Greg Wooden.

Treasures report was presented by Board Treasurer, Monica Mallon. Report was reviewed and discussed. Motion to approve-Dan Conrad, second-Richard Thompson.

Minutes from the October meeting were presented by Greg Wooden. Correction was made in reference to the approval of Greg's proposal to raise entry fees at our shooting events. The motion was approved by Richard Thompson (not Greg Wooden). Motion to accept corrected minutes-Monica Mallon, second-Jim Mallon.

OLD BUSINESS:

Triple Crown – Sign up genius will be used again. We need to do some clean up on the bales and move the end bale out and paint. Volunteer helped is needed. Will announce date later.

Thursday and Sunday leagues have started. Attendance is so/so.

The Board is submitting a proposal to increase the membership dues at the annual meeting.
